- Keep detailed records of pet care in the company's mobile app (Time To Pet)
- Watch for and communicate about unusual behavior, and arrange medical care when necessary.
- Report dangerous conditions immediately.
- Assist in arranging pet service schedules, when necessary.
- General care of home, such as watering plants, bringing in mail and packages,
- overseeing other service providers such as house cleaners, lawn care or pest control and other similar tasks.
- Ensure pet owners' homes are secure.
- Perform additional grooming services, i.e. nail trimming, after completion of additional training.
- Performing other duties as assigned.
